RTT DAYS WORKING TIME AGREEMENT : BE AWARE

The French Labor Supreme Court issued a ruling on October 16th 2019 regarding the validity of the RTT days working time agreements according to the date of their conclusions and their applicable collective bargaining agreements (CBA).

Employers, please check the following to avoid overtime disputes such as :

- The date your RTT working time agreement came into effect and the date on which CBAs have provided for one.
- If necessary, update the individual RTT days working time agreement of the employees at stake.
- And as always, comply with your obligations regarding the monitoring of working time, specific annual interviews, and the respect of professional and private life balance.

THE PSE-RCC PLATFORM IS ABOUT TO BE REPLACED

The transmission of information in the event of redundancy or collective termination (economic redundancy proposal, application for validation or certification of the collective redundancy, etc.) will be carried out through a new plateform entitled «RUPCO» on December 2nd 2019. This new plateform replaces the old one «PSE-RCC». From January 1st 2020, the employer will also be able to inform the DIRECCTE through the plateform, of the dismissals notified in the scope of a «small» collective economic dismissal (less than 10 employees).

ESTABLISHMENT OF THE CSE : Last days !

Ministry of Labor rejected unions request to postpone deadline to postpone deadline to elect a CSE. The deadline of January 1st 2020 is still on. If there is no election of the CSE within a company with more than 11 employees (over 12 consecutive months) on January 1st 2020, those companies could be prosecuted for obstruction.

If you have not proceeded yet, take that as a priority to minimize your risks.
