INTERVIEW WITH

# Daniel Kahn, Sabine Lipovetsky and Fabrice Perbost,

partners at Kahn & associés

Leaders League, Kahn & Associés' IT department is composed of 40 professionals. What are the main trends in the sector, especially regarding mergers and acquisitions, in key regions such as Asia and the US?

Daniel Kahn. We have been working internationally for thirty years in the high-tech sector, especially in Califormia and Israel. Over the past six years we have also increased our ties with companies located in Asia, mainly in China. A few main trends are rising on a global scale, be it in China or in the United States, without any regional disparities. First comes the development of digital tools, Internet, and cloud computing. Issues related to big data are also increasingly important, as they create new needs for data management operating systems. Another key trend is the emergence of Software as a Service (SAAS), which enables selling subscription to software instead of licensing rights. Last but not least, of course, the explosion of the social networks market, which is full of opportunities, as proved recently when Facebook took over Instagram. Acquirers and investors from all over the world are extremely interested in companies whose business model is grounded on one of those new dynamics.

### Leaders League. Your firm also has an IP team. Which are currently the most efficient strategies for the defense of IP rights?

Sabine Lipovetsky. Some practices are extremely efficient, especially when it comes to customs control. More and more guidelines, explicative documents and detailed reports enable easier enforcement processes and lawful customs entries. We notice that customs are increasingly committed to the

protection of our clients' interests, and are watching carefully the correct application of IP rights in general and trademarks law in particular: they are willing to evaluate the companies' rights and their counterfeiting risks in order to take appropriate actions. In addition, litigation related to illicit use of domain names is increasingly resolved via the UDRP and other fast and efficient non judicial dispute resolution procedures. Finally, tailored monitoring of the filing of trademarks, domain names and commercial names is a key action in the defense of trademark rights.

### Leaders League. Do you notice regional disparities regarding the application of IP law?

S. L. Developing countries such as China are now strongly willing to put in place a real IP rights protection system. Results are already there in China, be it from an administrative or a judicial point of view. We therefore encourage our clients, even smaller companies that have been really hesitating so far, to protect and enforce their IP rights in China. Their demand is increasing, in China but also in India, especially in the furniture, fashion, leather and jewelry sectors.

### Leaders League. What is your latest and most notable legal victory in terms of IP?

S. L. We have very actively and successfully defended the rights of our client, the Eiffel Tower operating company, in many cases. As an example, we won a case about the blue lighting of the Eiffel Tower used during the EU French presidency.

Leaders League. In IT and software law, does the cloud revolution

### have an impact on the structure of contracts?

Fabrice Perbost. Cloud computing does not have an impact on the contracts' structure itself. However, it implies paying more attention to some specific clauses regarding personal data management. Contract have to take into account much more than before all issues related to the location of data on servers, the kind of data concerned, the means of transfer etc. Clauses dedicated to filing processes, privacy protection and data recovery are therefore increasingly strategic.

The same goes for the Saas. As a remote access solution through subscription, with a login and a password, it requires specific clauses that are not needed in the case of a traditional software license acquisition contract. This has an impact on the contracts' elaboration, but also on the cost of the service, which may vary depending on the volume of data transferred and the subscription's duration.

### Leaders League. How do your clients react to the rise of compliance issues?

**F. P.** Compliance is indeed a topic of great importance for editors, especially in these times of crisis. More and more compliance departments are implemented, in order to hunt for illicit software use by clients. This process enables editors to benefit from additional revenues. It also leads to the creation of a dedicated taskforce involving technicians of course, but also finance experts in order to assess the prejudice and law professionals in order to take the appropriate actions. Surely, cloud and Saas will make thing change and help going toward a smoother dialogue between software users and editors. •
